Chief Appraiser Wayne Patrick, Brad Goss, Nikki Graham and Nichole Norman were present for the office staff.

Nichole Norman took minutes for the meeting.

Brad Goss opened the meeting with a prayer.

Ms. Brown called the meeting to order at 9:04 a.m.

Ms. Brown requested a motion to approve the agenda. Ms. Evans made such motion. Mr. Setchel seconded, and the motion passed 5-0.
