Franklin Hart Airport Authority Called Meeting Minutes

• 3:00 PM Call to Order

- Chairman Addison called the meeting to order at 3:00 PM
- Establishment of Quorum
 - Attendees: Eddie Addison (Chairman), Mike Ward (Vice-Chairman), Kevin McCraney (Secretary/Treasurer), Mark Brown, Woodson McFarlin, Johnny Coxx
 - Absent: Jonathan "Bo" Rowland
 - Guests: Danny Doyle (GDOT)
- Prayer
 - Mike Ward voiced a prayer.

Pledge of Allegiance

- Mike Ward led us in the Pledge of Allegiance.
- Approve Agenda
 - Eddie Addison made a motion to add "Lease Policy Discussion" under new business, seconded by Johnny Coxx, passed unanimously.
- Secretary Report
 - Approve Minutes from August 24, 2023 Meeting Motion to approve by Mike Ward, seconded by Johnny Coxx, passed unanimously.
- Treasurer Update
 - Kevin McCraney reviewed financial statements from August to December 2023. Special emphasis was placed on the declining balance in the operating account due to extraordinary expenses in 2023. Examples given: DBE (\$12K+), 2022 & 2023 financial audits (\$12K), hangar door repair (\$1,300), fuel island maintenance (\$2500).
 - The hangar loan was paid off in November at the Pinnacle Bank.
- Old Business
 - Runway Lighting Rehab Project Update Trinity has finished their punch list items per Eddie Addison. They have submitted pay request #2 to

Croy Engineering but the authority has not seen it. Trinity is inquiring on status. Pay request #1 was processed in 8 days from receipt of funds. Per Danny Doyle, ultimate responsibility for PAPI certification is sponsor. Eddie Addison to check on getting PAPIs certification. The authority will hold retainage until PA-PIs certified. Pay request #3 has also been submitted to Croy Engineering and the authority was copied on the email.

- Inspection Report Items Update Kevin McCraney will check with A&T Fence to get repairs requoted.
- Resurfacing Scope of Work IFE (Internal Fee Evaluation) requirements for engineering study were discussed. This is required for any engineering services over \$100K. Croy Engineering has submitted their scope of work for the runway resurfacing project. Danny Doyle said he would check on the IFE process and let us know how to proceed.
- Liability Policy Eddie Addison discussed Franklin County's general liability coverage of the airport required by enabling legislation. County will be covering. Attorney fees will also be submitted for reimbursement.

New Business

- GDOT Meetings meeting in January to discuss abuse/unreasonable requirements from GDOT, specifically Steve Brian. Failed reimbursement from GDOT for past DBEs was discussed. Clement Solomon (GDOT Director) committed to correct actions and move forward. Later meeting with Russell McMurray at the state capital and GDOT office. We have received commitments from GDOT to stop causing issues for the Franklin-Hart Airport Authority and move forward together.
- Supplemental Agreement to include DBE Reimbursement Danny Doyle discussed the supplemental agreement. This will add the past DBE reimbursement to the current lighting rehab project. This was a direct result of the meetings held at GDOT. Motion to approve by Kevin McCraney, seconded by Woodson McFarlin, passed unanimously.
- Timber Contract Mike Ward presented a contract from Harris Timber Company LLC for clearing the recently purchased 31 acres and approximately 18 acres of adjoining airport property. Motion to approve by Mike Ward, seconded by Woodson McFarlin, passed unanimously.
- Engineering Firm RFP Croy Engineering's contract expires in April 2024. Danny Doyle discussed the requirements for renewing/bidding the next contract and will send us more details on the process.
- Jet A Fuel License Titan Fuels recently made us aware that our Jet Fuel license has expired. If not renewed, the authority will have to pay a road tax on the next load of Jet A ordered equating to around 32 cents per gallon. According to the Georgia Department of Revenue, the license expired when the former authority administration stopped paying the sales tax in 2008. The license stays active as long as the taxes are paid. Kevin McCraney is investigating getting the license reinstated.
- Lease Policy Discussion GDOT has required us to formulate a lease policy for the hangars. Woodson McFarlin and Johnny Coxx are working on a draft due to GDOT by mid-February. Danny Doyle said he would send us a copy of the minimum standards.

- Chairman Addison discussed the recent airport update he presented at the Franklin BOC meeting and will soon be providing one to the Hart County BOC.
- 2024 Term Expirations Woodson McFarlin and Jonathan Rowland's terms expire in June 2024. Woodson McFarlin expressed interest in staying on the authority. Eddie Addison will check with Jonathan Rowland and communicate to Franklin County. McFarlin and Rowland are Franklin County appointees.
- **Adjourn** Kevin McCraney made a motion to adjourn, seconded by Johnny Coxx, passed unanimously. Meeting adjourned at 4:28 PM.
