|                     | <ul> <li>All Georgia Providers of IDD Services are still awaiting payment of the 5% rate increase which was effective July 1, 2022. This is impacting the financial position of over 500 agencies in the state.</li> <li>The extended fencing was installed at the Behavioral Health Crisis Center.</li> <li>Avita was "in the news" over the past month. The Milton Herald newspaper and Georgia Trend Magazine ran articles.</li> <li>Avita was very well represented at this year's Georgia Gathering, a conference for self-advocates</li> </ul>  |
|                     | <ul> <li>And this very then represented at this year's design outstending, or contention of a doodates held at Unicol State Park September 8<sup>th</sup> and 9<sup>th</sup>. Twelve staff and 14 Avita self-advocates were in attendance.</li> <li>As we focus on expanding our workforce, Avita's Human Resource Department has been participating in many job fairs over the past month. Some of the job fairs are specialized based on a department, while others are generally available to students of all majors. Avita was represented at the following career fairs: Georgia Gwinnett, Georgia Southern, Dalton State, Georgia College and State, University of North Georgia (Gainesville and Dahlonega), Hall County Chamber of Commerce, University of South Carolina, Appalachian State, University of North Carolina – Asheville, Middle Georgia College, University of Georgia, and Lanier Tech – Cumming.</li> <li>September is Suicide Prevention and National Recovery month. There are many events happening around our area in both September and October. Avita is represented at these events, raising awareness to treatment options we offer and sharing the message of Hope. A few of the events from the past month include: the Northeast Georgia Recovery Fest, Rally for Recovery, Hall County Recovery, Toccoa Overdose Awareness Candlelight Vigil, and Banks County Fall Festival and Health Fair.</li> <li>The University of North Georgia hosted the REED (Regional Education and Economic Development) Summit at their Dahlonega campus on September 20<sup>th</sup>. The theme for this year's Summit was "Transforming Healthcare in North Georgia." |   | <ul> <li>Deputy Director for DBHDD, and Cindy Levi discussed Georgia's mental health crisis, answering questions by the facilitator and the attendees.</li> <li>The Senate Study Committee on People with IDD and the Waiver Process held its 3<sup>rd</sup> of 5 meetings on September 21<sup>st</sup> at the Rome Civic Center. Cindy presented to the committee.</li> <li>Avita staff Cindy and Grace provided a Yellow Ribbon Suicide Prevention presentation to the Toccoa Senior Center on September 27<sup>th</sup>.</li> <li>After almost 6 months of negotiating, we are awaiting final signature from Alexander Properties Group on a settlement agreement after our claims of violating "The Fair Housing Act" by discriminating against the individuals served by Avita at The Pines of Lanier apartment complex.</li> <li>Over the past month, 2 presentations were made regarding Avita's services during County Commissioner Meetings: Dawson and Towns County.</li> <li>The Department of Justice sent a subpoena to produce data to Avita regarding the services provided through our APEX Program (counseling in schools). When all the reports were completed and everything compilated, there were over 16,000 pages of documents submitted.</li> <li>On September 30<sup>th</sup>, Avita will celebrate the career of a woman who has dedicated her life to serving others, Polly Thomas. Polly will be retiring after 27 % years of public service through Avita.</li> <li>The following staff have been recognized for going "Above and Beyond" over the past month: Rae Marie Emans, Jolyn Matheson, Diana Ward, Kenslei Kripner, Diana Cortes, Michele Malone, Victoria Williams, Michelle Brown, Kristina Royal, Emily Brown, Anne Campbell, and Lisa Cabe. | Financial Update  | <ul> <li>Greg Ball reviewed the following in his report:</li> <li>August saw a \$10,000 surplus.</li> <li>Current year revenues are \$445,000 (or 9.2%) above prior year revenues.</li> <li>Current expenses continue to be nearly spot on to our projections.</li> <li>Current year expenses are \$688,000 (or 15.1%) above prior year levels.</li> <li>Our Key Performance Indicators (KPIs) continued to exceed the targets established by DBHDD: <ul> <li>Cash on Hand is 85 days- still well above the 30 day minimum</li> <li>Current Ratio - 6.4:1</li> <li>Days of Covered Expenses - 66 days -still well above the minimum of 60 days</li> <li>Long Term Debt Ratio12:1 - same as last month - remains the same as we have minimal long-term debt</li> </ul> </li> </ul>  |
