1. Prayer

9. County Administrator's Report

County Administrator Terrell Partain announced Paynes Creek Campground and Long Point opens March 1, 2023 for the season; and thanked the BOC for giving him authorization to purchase a remount for EMS.

Chairman Sayer noted the county is still waiting for three new ambulances that have been on order; he appreciates the flexibility for the County Administrator to bid on or purchase used ambulances when they are available. He also announced the auto gate has been installed at Paynes Creek Campground; DCA has approved the SDS plan.

Commissioner Teasley inquired about the handicap ramp at the Library. Administrator Partain responded a ramp will not meet the ADA requirements.

Commissioner Dorsey reported DOT refused to put a secondary bridge on 29S therefore, traffic is being detoured on county roads which is not designed for heavy traffic; he's receiving complaints about truck traffic and damaging county roads in the area; he thanked the Sheriff's office and State Patrol for their assistance with wrecks that have happened on the detoured roads; suggested the county seek LMIG funds to repair roads damaged by truck traffic during the bridge construction on 29S.
