Hart County Board of Commissioners met March 14, 2023 at 6:00 p.m. at Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Chairman Sayer.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call To Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed those in attendance.

5. Approve Agenda

Commissioner Teasley moved to approve the meeting agenda. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

Commissioner Teasley moved to approve the minutes of February 28, 2023 meeting. Commissioner Dorsey provided a second to the motion. The motion carried 5-0.

7. Remarks By Invited Guests, Committees, Authorities 10U Boys GRPA State Runner-up Youth Basketball Team

The BOC offered congratulations to the 10U Boys Basketball Team and Coaches for placing State Runner-up for 2023 season.

8. Reports By Constitutional Officers & Department Heads

Attorney Kim Higginbotham reported paperwork for Service Delivery Strategy is close to being finalized; the lawsuit filed by the previous Probate Judge has been resolved in the county's favor by the Court of Appeals.

County Administrator's Report February Financial Report

County Administrator Terrell Partain presented General Fund Financial Report for the month of February; thanked the City officials involved with resolution to the Service Delivery Strategy; maps are being finalized; and wished Chairman Sayer "happy birthday".

#### 10. Chairman's Report

Chairman Sayer thanked the Board for allowing Commissioner Dorsey and himself to facilitate meeting with City officials; the City and County agreement were met which is beneficial for both entities; he thanked everyone that attended the SDS meeting.

#### 11. Commissioners' Reports

Commissioners Teasley, Brown and Dorsey offered condolences to the family of Paul Robinson.

Commissioner Brown thanked Chairman Sayer, Commissioner Dorsey, Attorneys, City officials, representatives from the Water Authority for the good outcome of the SDS meeting.

Commissioner Dorsey reported one of the issue discussed at the SDS meeting was water pressure flow for hydrants on Ridge Road; he will be meeting with Health Department's Supervisor over the Environmental Specialist to discuss issues with several county residents concerning permits for wells; S.C. towing company is repossessing vehicles from local businesses during the night without paperwork; concerned there could be a serious problem therefore, he asked County Attorneys to look into the issue.

Commissioner Brown moved to table the issue until March 28, 2023 meeting. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

## e) Bowersville De-annexation Resolution

Administrator Partain explained several residents from the City of Bowersville submitted signed petitions desiring to de-annex their property from the City of Bowersville into unincorporated Hart County.

Attorney Higginbotham reported 24 parcels and approximately 600 acres are involved in deannexation; mapping was reviewed and no island will be created by de-annexation; approval by the BOC resolution, petitions and resolution will be given to the property owners; decision will be at the discretion of Bowersville Council.

Chairman Sayer moved to approve the application of the residents to de-annex and adopt Bowersville De-annexation Resolution. Commissioner Brown provided a second to the motion. The motion carried 5-0.

Nancy Evans reported the Road Department has bladed Heath Cove and new gravel has been spread; asking for an additional load of gravel; reported someone has dumped 10-15 tires on Rock Springs Road. BOC directed her to talk with Code Enforcement concerning the tires.
