Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown and Joey Dorsey.

1. Prayer

Chairman Sayer called the meeting to order.

14. Public Comment

County resident Jim Gaines asked for Commissioner Dorsey to resign.

County resident Bill Leard presented a proposed plan for a 56-unit apartment complex on Parkdale Road for workforce housing funded through Department of Community Affairs; May 19 is the grant application deadline with DCA.

Apartment complex Developer Edward Libershal stated the proposed 12-acre site on Parkdale Road and asked for clarity since the property will not be subdivided; the proposed apartment complex will be similar to Juniper Court and Chandler Trace with two to three bedrooms at affordable rental.

Chairman Sayer responded the county took a stance to prohibit multifamily residences prior to the moratorium for the simple reason the county does not have a sewer system. Mr. Libershal responded the City of Hartwell has a lift station on Parkdale and would allow the use of their system.

Lisa Wilcox complained about a nuisance issue with a neighbor; barking dogs; cameras mounted and directed at her property and bright light shining at night prohibiting use of her backyard; and asked the BOC to consider an ordinance prohibiting this type of behavior.

15. Executive Session – Litigation/Personnel

Commissioner Dorsey moved to exit into Executive Session to discuss litigation and personnel matters along with two members of the Board of Assessors. Commissioner Brown provided a second to the motion. The motion carried 5-0.
