# Hart County Board of Commissioners June 8, 2021 6:00 p.m.

Hart County Board of Commissioners met June 8, 2021 at 6:00 p.m. at the Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Ricky Carter and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Commissioner Dorsey.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed those in attendance.

5. Approve Agenda

Commissioner Dorsey moved to amend and approve the agenda to remove item 12 j) Wisteria Cove, add 12 j) Floor covering – Tax Commissioner's Office; 15 Executive Session – Litigation. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

- 5/25/2021 Reg Meeting

Commissioner Teasley moved to approve the minutes as amended. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

7. Remarks By Invited Guests, Committees, Authorities

Matt Beasley commended Recreation Director Jim Owens for his service; expressed appreciation to the BOC for their participation in promoting tourism, MEGA ramp and for their service to Hart County.

8. Reports By Constitutional Officers & Department Heads

Attorney Walter Gordon commended Rhea Dignam for the research she provided the Corp of Engineers involving their Master Plan leading to a letter from the BOC requesting them to review their population projections for Hart County. The Corp has indicated a favorable response.

County Administrator's Report May Financial Report County Administrator Terrell Partain gave a summary of the General Fund and Payne's Creek Campground financial report for the month of May; reported Stratton Brothers Construction has ground up Orchard Road, adding base, crusher run and will pave the road next year.

# 11. Commissioners' Reports

Commissioner Teasley has received calls concerning growth around road signs; commended EMS, Law Enforcement, Fire and all other county employees for their service.

Commissioner Carter reported tree limb problems over county roads. Administrator Partain responded the side arm has limited height to reach limbs.

Commissioner Carter inquired about the Georgia Outdoor Stewardship Grant. Administrator Partain responded the Chamber of Commerce is checking on the grant; Archway students would need to be involved in design work. However, it is impossible to submit the grant application by August.

Commissioner Carter inquired about bids for the fire department. Administrator Partain responded a meeting is scheduled to discuss purchasing the building through State Contract.

Commissioner Carter reported there are grants available for Fire Departments; window was broken out at Shoal Creek Fire Department and read a letter from David Cagle.

Commissioner Dorsey responded David Cagle was ruled out of order multiple times; and slandered some of the members of the BOC publicly.

Commissioner Dorsey commended Little League for sponsoring the All-Star Tournament.

Commissioner Dorsey moved to enact a 120-day moratorium to issue permits for rendering plant(s). Commissioner Carter provided a second to the motion. The motion carried 5-0.

Commissioner Dorsey thanked Road Superintendent Shannon Teasley's crew for patching performed in Bowersville; and inquired about the process by which Municipalities share building permits with Hart County. Administrator Partain has discussed permitting with Bowersville; Code Enforcement has issued a number of citations for failure to acquire a building permit.

## 12. Old Business

Commissioner Dorsey moved to accept the 2<sup>nd</sup> Reading Amendment to Chapter 46 Land Development Standards Article V. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

Commissioner Dorsey moved to accept the 3<sup>rd</sup> and final reading Animal Control Ordinance Amendment. Commissioner Bennett provided a second to the motion. The motion carried 4-1 (Commissioner Carter opposed).

c) Replacement Ambulance for EMS

Commissioner Dorsey moved to ratify the purchase of a replacement ambulance through State contract. Chairman Sayer provided a second to the motion. The motion carried 5-0.

d) Georgia Mountains Regional Commission Board Appointment (BOC) (Tabled 5/25/21)

Commissioner Teasley moved to remove the item from the table. Chairman Sayer provided a second to the motion. The motion carried 4-1

Chairman Sayer moved to re-appoint Commissioner Carter to serve on GA. Mtns. Regional Commission Board. Commissioner Bennett provided a second to the motion. The motion carried 4-1 (Commissioner Dorsey opposed).

e) Open Records Open Meetings Training

Commissioner Dorsey announced he will conduct another Open Records Open Meetings Training Session June 24 or June 29, 2021.

f) Floor Covering - Tax Commissioner's Office

Commissioner Dorsey moved to award the replacement floor covering to Hartwell Flooring per quote of \$7,515.05. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

a) FY22 Hart Transit and Avita Community Partners Service Agreement

Commissioner Dorsey moved to approve FY22 Avita Community Partners Service Agreement. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

b) Old Hendry's Church Cemetery

Commissioner Dorsey reported Old Hendry's Church cemetery is the oldest in Hart County; no ownership to maintain it and according to State Law counties can maintain abandoned cemeteries.

Commissioner Dorsey moved for County Administrator Partain to reach out to Whitworth Parole Center to seek assistance for a crew to maintain the cemetery. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

c) Joint City County Meeting Discussion

Chairman Sayer moved to schedule a quarterly meeting with the City of Hartwell officials at the Literacy Center. Commissioner Carter provided a second to the motion. The motion carried 5-0.

d) Harbor Point Road – C&A Adventures, LLC Subdivision (Parcel C65 013)
