## 5. Remarks By Invited Guests, Committees, Authorities

Franklin County Planning Director Scott Deloizer has been the Planning Director since September 2020; the county established a fee schedule for building inspections; uses a third-party inspection company to perform inspections; from footings to finishing projects; permitting and inspections has been a positive impact for the county.

 County Administrator's Report July Budget Report

County Administrator Terrell Partain presented the General Fund and Payne's Creek Campground financial report for the month of July.

Commissioner Carter inquired about a suggestion box at the campground sites. Administrator Partain responded comments can be submitted on the website.

Administrator Partain reported he approved a Recreational Vehicle Park for 20 sites on 22.23-acre tract on Parkdale Drive for Care Investments, LLC. They met the requirements of County Ordinance Chapter 50, Article III Section 50-33.

#### 11. Chairman's Report

Chairman Sayer explained local citizens had input with the Comprehensive Land Use Plan adopted in 2018. The land use plan supports local agriculture industry and culture; the BOC reviews policies and ordinances for ways to direct growth towards cities and urban areas; plan suggested large 3 acre lots and conservation designed green spaces within subdivisions. The Land Use Plan is on the county website.

Commissioner Bennett thanked the Road Department employees for work performed in his district.

Commissioner Teasley commended Law Enforcement, EMS, Road for work performed on Ridge Road and all county employees.

Commissioner Carter inquired about amending the county ordinance for short term rentals. County Attorney Walter Gordon responded he will have an amendment ready for review at the next meeting.

Commissioner Dorsey congratulated Hart County Charter School Vocational Teacher Mike Carey for being named teacher of the year.

Commissioner Dorsey inquired about land covenants. Mr. Mauk responded he doesn't have a master set of covenants.
