Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Ricky Carter and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Commissioner Dorsey.

2. Pledge Of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call To Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed those in attendance.

5. Approve Agenda

Commissioner Teasley moved to amend and approve the agenda to include items 12 e) Grant Verification (CDBG-Water & Sewer Authority); 15 Litigation. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

9. County Administrator's Report

County Administrator Terrell Partain reported 86.24% of SPLOST V funds has been collected; results of the sales ratio appealed approved @ 38.15%; DOR has approved the 2021 tax digest and the grant application for Law Enforcement/First Responders has not opened up.

11. Commissioners' Reports

Commissioner Bennett inquired about bills for use of Flat Shoals Gym for the Health Department vaccination program. Administrator Partain responded as per the agreement with Flat Shoals Church they offered the use of the facility at no cost.

Commissioner Teasley thanked Law Enforcements, EMS, Fire and all other county employees for their services.

Commissioner Carter inquired about the status of Flat Shoals Bridge. Administrator Partain responded the project is in process.

Commissioner Carter commented it's time to get ACCG involved in annexation; inquired about the status of the new fire station; FEMA grant was awarded to Franklin County and why Hart County is not pursuing a grant.

Administrator Partain responded the new fire station site plan is being developed; and GA Mtns. RC filed for a FEMA grant two years in a roll.

Commissioner Dorsey reported there is an effort underway to get Lilly Sherman assistance at the Health Department; he received an email from someone in the republican party concerning the compensation and funds for the poll workers; the BOC approved increasing the hourly rate for poll workers from \$7.50 per hour to \$8.00 in the FY22 budget; and offered condolences to the family of former employee Carolyn Adams.

12. Old Business
