The Hart County Board of Commissioners met December 12, 2017 at 5:30 p.m. at the Hart County Administrative & Emergency Services Center.

Chairman Joey Dorsey presided with Commissioners R C Oglesby, Frankie Teasley, Marshall Sayer and Ricky Carter in attendance.

1. Prayer

Prayer was offered by Commissioner Sayer.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Dorsey called the meeting to order.

4. Welcome

Chairman Dorsey welcomed those in attendance.

5. Approve Agenda

Commissioner Sayer moved to approve the meeting agenda. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

7. Remarks By Invited Guests, Committees, Authorities Kinder Morgan Fire Department

Mrs. Kinder presented the Fire Department a donation of \$17,500 on behalf of Elba Express to purchase equipment for the fire department; she thanked Chief Byrum and Representative Alan Powell for their assistance during the grant application process.

9. County Administrator's Report

County Administrator Terrell Partain announced water testing around the old landfill site will be taking place within the week; bridge work Old 29 Road will start in February and letters have been sent out to waste haulers concerning the franchise process.

10. Chairman's Report Financial Report

Chairman Dorsey presented the financial report ending November 2017; in addition, he asks each BOC member to comment on the recent trip to Washington D.C.

Commissioner Oglesby reported he was very impressed with Vice President Pence; the news media is not reporting fairly for the business taking place in Washington; Commissioner Sayer stated VP Pence appears to support state and local governments and he was humbled for the experience; Commissioner Carter stated the trip benefited all attending and current administration is trying to build a relationship on a local level.

Chairman Dorsey added the trip was a very enlightening experience; NAFTA is scheduled to be renegotiated next year; Nations that are part of NATO are not paying their share; efforts are underway to streamline welfare. He also reflected on tax bills being sent out on time for the first time in years; the county ended with a solid financial year; all BOC members were together in the Christmas parade; thanked

the Chamber for their successful planning of the annual parade; recognized Commissioner Carter for receiving Commissioner of the Year through GA. Mtns. RC&D; and wished everyone Merry Christmas and Happy New Year.

12. Old Business

a) LMIG FY18

Commissioner Oglesby moved to submit Clay Brown Road (3.077 miles from State 8 to State 172, Eagle Grove School Road Pt. 1 2.055 miles from State 8 to CR92 Speedway Road, Mount Olivet Road parts 1b & 2 5.524 miles from CR187 Beacon Light Road to CR301 Boleman Hill Road, Mt.
