Library Director Richard Sanders requested funding to upgrade the lighting system at the Library which would be an estimated savings of 63%; projected cost of \$17,675.20; Georgia Power incentive of \$3,033; GPLS will fund one half of the project leaving the county's share \$8,837.60.
