Hart County Board of Commissioners met March 12, 2024 at Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Chairman Sayer.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Sayer called the meeting to order.

4. Welcome

Chairman Sayer welcomed those in attendance either personal, HTC or YouTube.

5. Approve Agenda

Commissioner Teasley moved to amend and approve the agenda to include item 12 e) Northpoint Subdivision Lots 20, 21, 22, 23 plat redraw; f) Level 1 Subdivision, Silver Oaks Homes, Parcel no C46 093 (6 lots) Seed Cleaner Rd./Well Rd. and item 15 personnel. Commissioner Brown provided a second to the motion. The motion carried 5-0.
