Hart County Board of Commissioners met January 23, 2024 at Hart County Administrative & Emergency Services Center.

Chairman Marshall Sayer presided with Commissioners Michael Bennett, Frankie Teasley, Jeff Brown, and Joey Dorsey in attendance.

1. Prayer

Prayer was offered by Commissioner Brown.

2. Pledge of Allegiance

Everyone stood in observance of the Pledge of Allegiance.

3. Call to Order

Chairman Sayer called the meeting to order.

4. Welcome

5. Approve Agenda

Commissioner Dorsey moved to amend and approve the agenda to include item 13 c) Nancy Hart School Road and Liberty Hill Church Road Intersection; 13 d) GDOT Bridge Replacement and item 15 Executive session – Personnel/Real Estate. Commissioner Brown provided a second to the motion. The motion carried 5-0.

12. Old Business

a) Amendment to Building Permits Chapter 18, Article II, Section 18.31(h) (3rd and Final Reading)

Commissioner Teasley moved to adopt the amendment to Building Permits Chapter 18, Article II, section 18.31 (h) as the 3rd and final reading. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

b) City of Hartwell Annexation of Parcel I57B 023 001

Commissioner Dorsey moved to remove the item from the table for discussion. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

Attorney Kimberly Higginbotham explained the annexation request would indeed constitute an unincorporated island in the county.

Commissioner Brown moved per legal advisement to object to the annexation request due to creating an island in the unincorporated area of the county. Commissioner Dorsey provided a second to the motion.

County resident Evans recommended the county surveyor review the boundary lines. Commissioner Dorsey responded that the county is on a timeline to respond to the City of Hartwell's annexation request.

Chairman Sayer called for the vote. Motion carried 4 - 0 (Commissioner Teasley abstained).

13. New Business

a) 2024 Recreation/Little League Facility use Agreement

Commissioner Dorsey moved to approve the 2024 Recreation/Little League Facility Use Agreement. Commissioner Teasley provided a second to the motion. The motion carried 5-0.

b) Chestatee-Chattahoochee RC&D board appointments

Commissioner Dorsey moved to appoint Commissioner Bennett to serve on the Chestatee-Chattahoochee RC&D. Commissioner Teasley provided a second to the motion. The motion carried 4-1 (Commissioner Bennett abstained). (term expires 12/31/2024)

c) Nancy Hart School Road and Liberty Hill Church Road Intersection

Commissioner Bennett suggested installing double stop signs and dangerous intersection signs on Nancy Hart School Road. The BOC agreed to the suggestion and will continue to resolve the dangerous intersection.

d) GDOT Bridge Replacement

Commissioner Dorsey moved to place Old Henry's Church Road on the GDOT Bridge Replacement list. Commissioner Bennett provided a second to the motion. The motion carried 5-0.

14. Public Comment

Chairman Sayer announced Hart County Little League will host a fishing tournament February 11, 2024 at Gum Branch Mega Ramp.

Nancy Evans of Heathwood Circle reported Heathwood Cove, Wren Road and Heathwood Circle have not been county maintained; roads have washed away; issues with grit and dust from the gravel; she questioned if LMIG funds can be used to pave the roads mentioned above and noticed there was not any road projects designated in SPLOST VI.

Chairman Sayer explained the BOC is researching TSPLOST requirements before calling for a referendum.

Commissioner Dorsey stated SPLOST VI funding is designated for the new jail facility loan payments, fire improvements, water, and economic development as approved by the voters.

Commissioner Dorsey moved to exit into Executive Session to discuss personnel and real estate matters. Commissioner Brown provided a second to the motion. The motion carried 5-0.
