Be sure that all hose is secure on all Fire Trucks. The other one was being paged out to a structure fire and not checking the structure out. Make sure that you stop and check the structure out good and even if you are 10-22 (canceled) go and check it out anyway.

Randall Simpson discussed which way was best to pay fireman by the fire and meeting or a set amount per year. Chief Byrum stated that he would look into it.
