Minutes of the Quarterly Meeting - July 27, 2009

Subject:

The Joint Development Authority of Franklin, Hart and Stephens Counties met at 211 Main Street Restaurant in Lavonia at 6:00pm on July 27, 2009.

- I. <u>Call to Order</u>- The April meeting of the Joint Development Authority was called to order by Chairman Cary Bennett.
- Introductions Chairman Bennett welcomed Michelle Doster, with the Franklin

#### OneGeorgia Grant:

Jack Edmunds reported the rail spur construction had been completed. As soon as grass planted on the disturbed area has germinated the engineers will be able to issue their final report and funds can be drawn from OneGeorgia. A final report should be ready by our next meeting.

JDA Marketing Materials: Lyn Allen reported that she and Michelle Doster had updated information and that it is ready to be sent to Georgia Power for printing.

Chairman Cleveland asked for any other old business. There was none.

#### IX New Business-

FYE 6/30/10 Budget: Treasurer Edmunds presented the proposed budget, that must be submitted to the U.S. Dept. of Agriculture. Treasurer Edmunds answered any questions regarding the budget. Vernon Edwards made a motion that the budget be accepted as presented with a second by Cary Bennett. The budget was accepted. A copy is attached as a part of these minutes.

Gateway Fire Protection Agreement: Dwayne reported that an agreement is being prepared between the City of Lavonia and Gateway for fire protection to be provided by the Lavonia Fire Department and back-up to be provided by the Shoal Creek Volunteer Fire Dept. With Lavonia FD providing service the ISO rating will meet the advertised rate for Gateway. Dwayne asked that the chairman be allowed to sign the agreement when it is ready. Roy Crocker made the motion to allow Chairman Cleveland to sign the agreement on behalf of the JDA. Vernon Cape seconded the motion and the motion carried.

Check Signing Resolution: Bank resolutions were presented authorizing signatures on the Authority accounts. The chairman recommended we continue requiring two signatures on checks and that any two of the four officers be authorized to sign. On a motion by Cam Parker, seconded by Mayor Ralph Owens the recommendation was approved. The motion also authorized the secretary to certify these requirements to the banks as they might require.

Project Developer's Caravan: Lyn Allen reported that the State project managers caravan is scheduled for September 1, 2009. The managers will visit sites in Franklin, Hart and Stephens Counties that morning with lunch being provided.

Work Ready Report: Lyn reported that Franklin County has received their State Certification. Tim Martin reported that Stephens County has almost reached the 95% to attain certification. Dwayne reported that Hart County has attained the Community of Excellence designation by the state
